It should be carefully noted that:

1. Counseling will be strictly on the basis of merit and reservation policy adopted by the Govt. of Tripura.
2. Delayed reporting by a candidate will cause loss of merit seniority. Such candidate will be eligible for counseling among the rest available seats in his /her category at the time of reporting.
3. Nomination of candidates is provisional. Any discrepancy/ shortfall found in relevant documents at any stage of counseling and also at later stage even after admission may lead to cancellation of nomination/ Admission of the candidate.
4. Nominated / Selected candidate must take admission within the date specified in nomination letter in the Institute where he /she has been allotted a seat.
5. During the counseling session there is no provision for change of branch or Institute once a particular seat is opted and allotted to a candidate. A candidate may opt not to accept the seat allotted to him/ her according to his/ her merit position, in such cases the candidates may appear for next phase of counseling. The candidates may surrender the seat even after allotment of the seat up to the last date of admission mentioned in the letter of nomination to the respective Institution. In such case he/ she may appear for next counseling.
6. Eligible candidates are further advised to visit the website www.wptripura.nic.in at regular interval to be aware of updates, if any.
7. Physical appearance of the candidate at the counseling is must.
8. All the candidates are directed to bring all related documents in original falling which selection will not be considered.

9. Nomination of the candidates who do not take admission nor surrender the seat within the date specified for admission in the letter of nomination will be deemed to be cancelled and they will not be considered for admission in this session.
10. There is a scope of changing branch within the college according to merit if there is any seat vacant,. The change of branch will be done within the college only on the day following the last date of admission after 1st phase of counseling.
11. Only one guardian of the candidate is allowed to accompany with the candidate inside the counseling hall.
12. In case the counseling cannot be completed within the specified date and time in such case the counseling for remaining applicants will be conducted at Women's Polytechnic, Hapania on 20th July, 2017 from 10:00 AM.
